ANNEXURE II: GENERAL TERMS AND CONDITIONS

1.The sealed cover containing the quotation should be super scribed with quotation No: MTU/REP & MAINT/8/7/CUP /2024 Dated 1/02/2024 quotation name REPAIRING OF RENDERING PLANT AND PUTTING IN RUNNING CONDITION as indicated above and should be addressed to the Associate Professor and Head Meat Technology Unit, Kerala Veterinary & Animal sciences University, Mannuthy-680655, Thrissur, Kerala.

2.The quotation should be in the prescribed form which is attached (Annexure III).

3.Intending quotationers should send their quotation so as to reach the officer mentioned below, on or before the due date and time. Quotations received after the specified date and time will not be accepted on any account.

4.The quotation will be opened on the appointed day and time in the office of the undersigned, in the presence of such of those quotationers or their nominees who may be present at that time.

5.Selected firm/bidder will have to remit security deposit @ 5% of the total value of the rate quoted, drawn as DD in favour of Associate Professor and Head, Meat Technology Unit, payable at SBI, Ollukara

6.The price quoted should be inclusive of all taxes and other charges if any.

7.All conditions of Kerala government tender/quotations are applicable in this case also. Future information can be had from the office of the Associate Professor & Head Meat Technology Unit during office hours (9 am to 4pm).

8.Warranty details should be clearly stated(minimum one year).

9.The supply of the items and running of the rendering unit should be conducted within fifteen days from the date of confirmed work order.

10. Bid should be clearly typewritten and every correction in the bid should invariably be attested with full signature by the bidder with date, failing which the bid will be ineligible for further consideration. There should be no overwriting/corrections.

11. Price Quoted should be valid for minimum one month from the opening of the quotation. A bid valid for a shorter period will be rejected as non-responsive. The Meat Technology Unit makes every endeavor to finalize the bids in the original validity period of the bids. However if for any reason, The Meat Technology Unit is not able to finalize the quotation within the original validity period of the bids, Meat Technology Unit may solicit the bidders consent for an extension in the period of bid validity. A bidder may refuse the request without forfeiting their bid security.

12. No handling, clearing, transport charges etc., will be paid. The deliveries should be made as stipulated in the purchase/work order placed with successful bidder.

13. Any deviation from the quotation form (annex I) should be made in a tabular form in the quotation .

14. The undersigned deserves the right to accept/ reject any/all quotations without assigning any reason. All other rules and conditions for the quotations prevailing in Kerala Veterinary and Animal Sciences University will be applicable to this quotation notice also.

14. We are exempted from payment of customs and excise duty for our procurement and hence price quoted should be exclusive of these prices. The supplier should inform well in advance for sending custom duty exemption/ excise duty exemption papers.

15. The price quoted should be in INR (inclusive of all taxes)

16. All the rules prevailing in the Kerala Veterinary and Animal Sciences University regarding the quotation will also be looked into this also.

a) The bidder shall supply only new, unused spare parts/items mentioned above (annexure- 1) without defect arising from material, workmanship or from any act or omission of the supplier that may develop under normal use of the supplied items and shall provide comprehensive warranty for a period of minimum one year

b) During the warranty period the bidder will be responsible for ensuring that the equipment is maintained in good working condition. Replacement of defective parts (supplied by selected bidder) of the equipment is done promptly free of cost at the place where the equipment is installed. Complaints would be attended to by the supplier promptly within one days of lodging of complaint and in no case the delay in attending to complaint shall exceed 3 days.

21. Amount Quoted should be inclusive of freight, loading, unloading, complete installation, dismantling, recommissioning etc.
