Applications are invited for admission to the following programmes offered by Kerala Veterinary and Animal Sciences University during the academic year 2024-25.

Name of the Programme	Eligibility
Ph.D. in Veterinary and Animal Sciences	Masters Degree in the respective/ related subject recognized by University with OGPA of 7.5/10 or equivalent OGPA/ equivalent percentage of marks at Master's Degree level. For SC/ST/PwD candidates the OGPA shall be 7.0/10 or equivalent.
Ph.D. in Dairy Sciences and Technology	Masters Degree in the respective/related subject recognized by University with OGPA of 7.5/10 or equivalent OGPA/ equivalent percentage of marks at Master's Degree level. For SC/ST/PwD candidates the OGPA shall be 7.0/10 or equivalent.
Ph.D. in Biosciences	<p>a) Persons having passed Post Graduate Degree (Master's Degree in any Life Science subjects) Examination with at least 50% marks or equivalent Overall Grade Point Average (OGPA) or an equivalent degree recognized by UGC are eligible to apply. For SC/ST/differently abled candidates, the minimum marks required for application is 45% in the Post-graduate Examination.</p> <p>b) Candidates possessing a Degree considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to PhD programme.</p>

Ph.D. in Climate Change in Animal Agriculture	M.V.Sc./M.S.(Integrated) CCA / PG degree in Agriculture Sciences/ Fisheries/ M.Sc. Biological Sciences/ Physical Sciences, with at least 50% marks or equivalent Overall Grade Point Average (OGPA) are eligible to apply. For SC/ST/PwD candidates, the minimum marks required for application is 45% in the Post Graduate Examination. In-service candidates who wish to apply to this programme should have published a minimum of two peer reviewed research articles.
M.V.Sc.	Bachelor's degree in Veterinary and Animal Sciences recognized by the University with an OGPA of 6.0/10 or equivalent OGPA/ equivalent percentage of 50% marks in traditional system. For SC/ST/PwD candidates the OGPA shall be 5.5/10 or equivalent.
M.Tech.	Bachelor's degree in Dairy Science and Technology/ Dairy Technology recognized by the University with an OGPA of 6.0/10 or equivalent OGPA/equivalent percentage of 50% marks in the traditional system. For SC/ST/PwD candidate the OGPA shall be 5.5/10 or equivalent.

Note: Those who have appeared for the final examination of qualifying degree and awaiting results can also apply. Such candidates have to submit their final result notification on the date of Entrance Examination. Mandatory relaxations are applicable for every category as per the existing government rules.

Selection to the Programmes will be done as follows:

Programme	Selection Process
<b>Ph.D programmes</b>	Selection shall be done from the rank list prepared on the basis of the OGPA secured in the qualifying exam, score in the entrance exam, Publications, Experience (as per score card) and viva-voce/interview conducted by the committee constituted by the University.
<b>M.V.Sc. Programmes</b>	Selection shall be done from the rank list prepared on the basis of the OGPA secured in the qualifying exam, score in the entrance exam, experience, publications and extracurricular activities if any (as per score card). Preference will be given to the graduates of KVASU and students completed 7 years of study in Kerala/ Kerala origin.
<b>M.Tech. Programmes</b>	Selection shall be done from the rank list prepared on the basis of the OGPA secured in the qualifying exam, score in the entrance exam, experience, publications and extracurricular activities if any (as per score card).

Candidates, who are eligible for the programme and seeking admission, have to apply on-line through the University website <https://application.kvasu.ac.in/> up to 5<sup>th</sup> October 2024. **All such candidates are directed to go through the Prospectus published by the University before registering in the online application portal.** Issuance of hall ticket for the Entrance Examination, counselling and changes in the admission procedure, if any, will be intimated through the News and Announcement section in the University Website. Therefore, **the candidates applying for the programme are directed to check the University website regularly and kindly note that there will not have any special intimation for the students.**

Incomplete or defective applications will be summarily rejected.
