ORDER

As per the Government Orders read as 1st and 2nd above, Government have implemented UGC 7th scheme in the Universities and colleges of the state. In consonance with the decision taken in 66th meeting of Board of Management held on 10.06.2020, UGC Regulations 2018 has been implemented in KVASU.(Ref 3&4)

Applications were submitted by teachers, to consider for grant of promotions to higher stages under the Career Advancement Scheme as provided under UGC Regulations 2018, against University circular read as 5th above. Preliminary verification and Scrutiny of applications were carried of by the committee constituted for the purpose. Accordingly, promotion proposals were considered by Hon'ble Vice Chancellor and issued directions to further processing.

Subject wise selection committee for promotions to the post of Professor (Academic Level 14) held its proceedings for approval of promotions proposals in the chamber of Vice Chancellor from 19.02.2024 to 21.02.2024. On the basis of minutes of the meeting of Selection Committee, proposal to grant promotions to 9 eligible applicants in different disciplines was placed before the Board of Management in its 86th meeting held on 22.08.2024. In consonance with the decision of BoM, 9 nos of Associate Professor (Academic Level 13A) are granted promotion as Professor (Academic Level 14) in the entry pay Rs. 1,44,200/- as given in Annexure to this Order.

The promotion granted as per this order is subject to the following conditions.

- This order is subject to verification in the Finance Wing for authorisation of pay in the matrix corresponding to promoted post.
- The post held by the incumbent will stand upgraded to the promoted cadre post upon granting the career advancement promotion and the post so upgraded will automatically be downgraded to the respective entry cadre post on his/her retirement/relinquishment of the post.
- 3. The date of effect of the promotion mentioned in this order is purely provisional and subject to review.
- 4. The incumbent should submit his/her option and declaration for the fixation of pay within one month of this order to the Finance officer with a copy to this office. Pay of incumbents shall be fixed observing provisions in the relevant Govt. Orders
- 5. Guidelines will be issued separately from Finance wing with respect to processing of arrear claims as per this order.
- 6. Salary/arrears drawn by the incumbent by this order if any fund to be excess due to mistake or any other reason, noticed later, he/she would be liable to

refund the amount so received in lump to the University.

7. Necessary entries will be recorded in the CAP register.
