### TENDER NOTICE

Sealed competitive tenders in the prescribed form are invited from those desires for supplying Generic Drugs and Vaccines (mentioned in the Annexure III B), to various departments, stations, farms and hospitals of Kerala Veterinary and Animal Sciences University (KVASU) on running contract basis for one year with effect from 01.04.2025 or till a new running contract is implemented.

- The tenderers, along with the tender form shall submit the ‘General Condition’ (Annexure I) duly signed and, an agreement on Kerala State Stamp Paper worth Rs. 200/- (Rupee Two hundred only), in the given format (Annexure II) with the Tender Form.
- The firms having exemption for paying EMD shall produce necessary certificate.
- Firms shall keep copies of commercial tax/ GST Registration Certificate and Drug License along with the tender form.
- The bidders should submit their proof for three years’ existence in the market (income tax return/ registration certificate of the firm/ commercial tax registration certificate of the past three years).
- To assure the quality of products/ medicines/ vaccines called for, the bidder should quote the patent names of each brands they are quoting for, and their respective prices in their tender. Also products from firms with GMP certificate will alone be accepted.
- The items should have at least one year of expiry period from the time of supply.
- The rate should be quoted in the space provided for the purpose in the ‘List of Items’ (Annexure III B). Additional offers if any on supply of the items in bulk may be specified in ‘Remarks’ column against each item. Any addition deletion or alterations in the ‘List of Items’ are not allowed.
- The firms shall mention the brand of the item quoted and they are free to quote more than one brand of the same item that they can supply.
- The firms/ individuals can quote for all the items included in the list, or a part there of. The rates quoted shall be excluding GST. The rate of tax and the rate inclusive of GST for each item shall be mentioned in the concerned columns.
- The tenders received within the time fixed for the purpose will be opened at 3.00 PM on 17.02.2025 in the presence of tenderers or their authorised representative present at that time. The undersigned reserves the right to reject the tenders, or cancel the tender procedures without showing any reason thereof.
- The firms/ individuals who have quoted the lowest rate for each item/ brand and satisfying all tender requirements for various items will be requested
  1. to enter into an agreement with KVASU in Kerala Stamp paper worth Rs.200/-
  2. to remit the security deposit as prescribed by the KVASU.
- Those entering into running contract with KVASU shall be liable to supply the items at the rate quoted by them at any time during the period of the running contract *ie*, one year from 01.04.2025, or till a new running contract is entered into, to the stations/ departments/ farms of KVASU as per

their orders. The suppliers are not eligible for any freight charges. Payment will be made from the stations/ departments/ farms of KVASU which has placed the orders.

- The firms entering into contract should supply the items to any station or unit within the state jurisdiction of KVASU at the rate mentioned in the tender, failing which, it will be treated as breach of contract. In such cases, the contract will be terminated and the firm/dealer is liable to be black listed by the KVASU.
- Similarly, if the items supplied are found to be not of standard quality or misbranded or adulterated or spurious or otherwise contravenes the provisions of the Drug and Cosmetic Act or Rules also will be considered as a breach of contract
- The security deposit will be forfeited, if any of the firms fails to abide to the conditions mentioned in the tender notice and agreement
- Arbitrations and disputes, if any, shall be restricted to the jurisdiction of District court at Kalpetta
- All the rules pertaining to store purchase in Govt. of Kerala is applicable in this case also
- A soft copy of the filled rates should be provided in a CD. Separate CD should be provided for each tender.
