Qualification

1. Minimum 55% marks at Master’s Degree in Clinical Medicine/ Animal Reproduction , Obstetrics & Gynecology / Veterinary Surgery & Radiology / Veterinary Epidemiology and Preventive Medicine from an Indian University. *Note: In the absence of candidates with the required qualification, Post graduates from other disciplines shall also be considered.*
2. The candidate must have cleared the National Eligibility Test (NET) conducted by UGC, CSIR or similar test accredited by the UGC like SLET/NET.

Note :

i) As per University Grants Commission Regulation-2016, candidates who have obtained Ph.D degree in the concerned subject are exempted from passing the NET examination.,

(ii) For recruitment to this post, Degrees awarded by Universities recognized by ICAR/UGC alone shall be considered.

(iii) Candidates who claim an equivalent qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.


