ORDER

The University has decided to conduct the election to the Board of Management from the members of the 5th Management Council of the University. As per clauses 405 & 406 of the KVASU (First Amendment) Statutes, a Returning Officer and Assistant Returning Officer is to be appointed for the smooth conduct of the election. Accordingly, proposal has been submitted to Hon'ble Vice Chancellor and obtained approval .

In the circumstances, following orders are issued:

- 1) Shri. Dinesan A. K, Finance Officer, KVASU, is appointed as the Returning Officer for the election to the Board of Management from the members of the 5th Management Council of the University.
- 2) It shall be the general duty of the Returning Officer at any election to do all such acts and things as may be necessary for effectually conducting the election in the manner provided by the Statutes.
- 3) The Returning Officer may, for sufficient cause with the previous consent of the Vice-Chancellor, postpone the date or dates fixed in the programme for publication of final list of valid nominations, for despatch of ballot papers, for all or for scrutiny and counting of votes, when at any intermediate stage of an election any objection to any question is raised which necessitates the postponement of the programme.
- 4) Shri. Michael Murali. P, Deputy Registrar, General Administration, KVASU, is appointed as the Assistant Returning Officer for the election to the Board of Management from the members of the 5th Management Council of the university.

5) Every Assistant Returning Officer shall, subject to the control of the Returning Officer, be competent to perform all or any of the functions of the Returning Officer:

Provided that no Assistant Returning Officer shall perform any of the functions of the Returning Officer which relate to the counting of postal ballot and announcement of the result of election, unless the Returning officer is unavoidably prevented from performing the said functions.
